ABOUT THE CONFERENCE

ach year, at least 1.6 million women in the U.S. are assaulted by their partners and over 900,000 children are maltreated. It has been estimated that partner and child physical abuse and maltreatment co-occur in about 6 percent of all U.S. households. In homes where physical violence occurs toward a partner, the incidence of maltreatment of children rises to 40%. Children of battered women have higher rates of internalizing and externalizing behavior problems than do children raised in nonviolent families.

In terms of percentages, 28 percent of married couples in the U.S. experience violence over the entire length of their marriage, and family violence tends to be repeated. What can be done to screen and identify family violence and to prevent its occurrence? How can communities and clinicians respond in an ethnically and culturally sensitive manner to prevent such violence and to provide effective interventions? How can one develop culturally competent intervention programs for victims and batterers? What can doctors, nurses, teachers, clinicians, police and judges do to address the epidemic of family violence? In order to address these and related challenging questions, The Melissa Institute has assembled leaders in the area of family violence who have expertise in working with various populations. Drs. Fernando Mederos and Etiony Aldarondo are leaders in the field of eliminating domestic violence in Latino populations. Dr. Diane Kelly has an extensive background working with families in Palm Beach County. State Attorney Barry Kirscher is a strong proponent for providing assistance to victims and their families. Dr. Donald Meichenbaum, research director of The Melissa Institute, will complement this distinguished panel by offering practical, research-based ways to intervene.

The conference will highlight the legal ramifications of family violence and the impact of policy decisions. There will be opportunity for discussion and audience participation. 

Behaviors (which often co-occur with trauma reactions). In a survey reported in American Psychologist, Dr. Meichenbaum was voted "one of the 10 most influential psychotherapists of the century." He is research director of The Melissa Institute.

Diane Kelly, Ph.D., is currently the Chief of Clinical Services, Education and Training within the Palm Beach County Youth Affairs Division. She develops community-based programs for delinquency prevention and effective parenting. She conducts continuing education training for mental health professionals and serves as training director for graduate students and interns. She is a clinical psychologist
