ABOUT THE CONFERENCE

The events of September 11, 2001, have underscored the impact of violence. Whether aggressive behavior takes the form of terrorism, school shootings, domestic violence, road rage, or more everyday forms of aggression, there is an urgent need to take stock of possible preventive and treatment interventions. The conference begins with a consideration of an often-overlooked emotion of anger and its relationship to aggressive behaviors. The initial focus is on the nature of anger and the role it plays in such diverse forms of aggression as child abuse, conduct disorder, battering and terrorism. A life-span perspective will be offered to explain how aggressive behavior develops. The implications for assessment, treatment, prevention and risk management will be discussed.

Since angry and aggressive behaviors are influenced by such diverse sources as parents, peers, schools and community, there is a need to examine angry-aggressive behaviors across multiple settings. How some families go about the unwitting process of "training" their children to emerge with serious anger-related behavior problems will be addressed. Is there effective help for these children and their families? Moreover, what role does the school play in the problematic child's journey to prison? School policies and the behavior of school personnel are pivotal in deciding the outcome for children with anger and aggressive problems. Methods that school personnel can use to alter this

"career path" will be demonstrated by reviewing a number of local Melissa Institute violence prevention interventions.

The afternoon sessions provide an opportunity for more intensive practical workshops on interventions with problematic children/adolescents (with James Larson, Ph.D.) and with angry and aggressive adults (with Donald Meichenbaum, Ph.D.). Conference participants will be asked to choose one of these two workshops ahead of time.

Drs. Meichenbaum and Larson have each written major handbooks that will provide the texts for their workshops.

WORKSHOP I – Treatment of Adults with Angry and Aggressive Behaviors Donald Meichenbaum, Ph.D.

In this workshop, Dr. Meichenbaum will consider specific cognitive-behavioral procedures for individuals who evidence a variety of aggressive behaviors (e.g., road rage, suicidal behavior, anger plus comorbid psychiatric disorders). He will also consider what “expert” therapists do or the core tasks of psychotherapy employed in treating angry/aggressive individuals. A number of specific therapy procedures will be examined including stress inoculation training, emotional regulation, cognitive restructuring, skills training and relapse prevention. The role that victimization plays in contributing to aggressive behavior will be considered and the implications for treatment will be examined. Methods for employing

cognitive-behavioral interventions in individual, group, couple and family/community treatment settings will be discussed.

WORKSHOP II – Treating Angry, Aggressive Children and Youth: Group Interventions for the School Setting James Larson, Ph.D.

In this workshop, participants will be introduced to two cognitive-behavioral group interventions with demonstrated effectiveness in the school setting (the Anger Coping Program for 8- to 12-year-olds and the Think First Anger and Aggression Management Program for Secondary Level Students). Intervention procedures include self-instruction, self-monitoring and social problem-solving. Generalization issues will be discussed in depth.

CONFERENCE DIRECTOR

Suzanne Keeley, Ph.D., is President of The Melissa Institute and a psychologist in private practice with extensive clinical experience treating victims and perpetrators of violence. She is on the medical staff of Baptist and South Miami Hospitals, not-for-profit affiliates of Baptist Health South Florida.

FACULTY

Donald Meichenbaum, Ph.D., is Distinguished Professor Emeritus at the University of Waterloo, Ontario, Canada, and Research Director of The Melissa Institute. He is one of the founders of cognitive-behavior therapy. In a survey reported in *American Psychologist*, he was voted "one of the 10 most influential psychotherapists of the century." He has published extensively, and his most recent book is *Treatment of Individuals with Anger-control Problems and Aggressive Behavior*. Other books include *Treating Adults with Post-traumatic Stress Disorder; Nurturing Independent Learners*; and *Stress Inoculation Training*.

James Larson, Ph.D., is Professor of Psychology and Director of the School of Psychology Training Program at the University of Wisconsin, Whitewater. He is also a member of the Scientific Board of The Melissa Institute. His recent book (with John Lochman, Ph.D.) is *Helping School Children Cope with Anger: A Cognitive-behavioral Intervention* (2002, Guilford Press). Dr. Larson has more than 25 years' experience with the

study and treatment of anger-related behaviors in children and youth. He was a school psychologist with the Milwaukee Public Schools for 14 years and directed their Violence Prevention Program. He also has extensive experience in the area of parent management training and is the co-author (with Judith McBride, Ph.D.) of *Parent to Parent: A Video-augmented Training Program for the Prevention of Aggressive Behavior in Young Children*.

KEYNOTE SPEAKER

Marvin Dunn, Ph. D., is the chairperson of the Psychology Department of Florida International University. He co-authored *The Miami Riots of 1980, Crossing the Bounds*, an important work on civil disturbance in America. Throughout his career, Dr. Dunn has worked for positive social change and justice. He conducted workshops on conflict resolution and counseled victims of violence in South African cities. He also served on the Goldberg Commission on Violence in South Africa.


