### ABOUT THE CONFERENCE

This second annual conference is dedicated to the memory of Melissa Aptman, a charming and gifted young woman who was tragically murdered on May 5, 1995. In her name, family and friends founded the Melissa Institute, turning their grief into social action.

The focus on "Helping children and families at risk" fulfills part of the Institute's mandate: to help those in need. Any efforts to reduce violence should be informed by the research findings on those children and families who live in high-risk environments (poverty, crime, exposure to various stressors), but who, in spite of the odds, seem to "make it."

This conference brings together experts in the areas of education, clinical practice and community interventions, to identify and critically evaluate what research findings

indicate are **protective factors** and the practical implications for developing prevention and intervention programs. In both conference presentations and in the smaller break-out sessions, these experts will detail practical ways to establish, implement and evaluate specific programs. Their presentations range from the classroom to the school yard to the entire community.

A second mission of the Institute is to nurture a dialogue among practitioners, policy makers and researchers. In the setting of a town hall meeting, this year's conference faculty will discuss with Miami leaders the alternative strategies for prevention and treatment of violence.

If you attended last year's conference, you know that it was an exciting, stimulating day. Our second annual conference promises to be that — and more. We hope you will join us!

## **CONFERENCE DIRECTOR**

**Suzanne L. Keeley, Ph.D.**, is president of The Melissa Institute and a psychologist in private practice. She is also affiliated with Baptist Health Systems of South Florida. She has had extensive clinical experience treating victims and perpetrators of violence.

## **SCIENTIFIC BOARD OF THE MELISSA INSTITUTE**

**Donald Meichenbaum, Ph.D.**, is a professor of Clinical Psychology at the University of Waterloo, Ontario, Canada, and one of the founders of cognitive behavior modification. He has lectured worldwide on the impact of violence and has published a major *Clinical Handbook on Post-traumatic Stress Disorder*. In a recent survey reported in *American Psychologist*, he was voted by clinicians to be "one of the 10 most influential psychotherapists of the century." He is a founding member of The Melissa Institute.

**James Larson, Ph.D.**, is a professor of Psychology at the University of Wisconsin-Whitewater, and coordinator of the School Psychology Training Program. He is a leader in violence prevention in the schools and has developed videotape training programs for children and adolescents. His training manuals and materials have been widely used. He is also an expert in parent management training programs.

**Clifford O'Donnell, Ph.D.**, is a professor of Psychology at the University of Hawaii, and director of the Community Studies program. He is an authority on childhood aggression and violence. He has addressed the issue of gun control and youth. He brings an international perspective to the meeting, having developed culturally compatible community programs for youth and their families.

**Debra Pepler, Ph.D.**, is a professor of Psychology at York University, Toronto, Ontario, and director of the Judy LaMarsh Center for Research on Violence and Conflict Resolution. She is a leader in the area of the developmental correlates of childhood aggression, victimization/bullying and an expert on school-based interventions. She has also studied domestic violence.

**Barbara H. Wasik, Ph.D.**, is a professor of Education and director of the University of North Carolina Center for Home Visiting, Chapel Hill. She is a pioneer and leading authority in the areas of home visiting and family literacy programs. Her book on *Home Visiting: Procedures for Helping Families* (Sage Publishers) is a classic in the field. She has consulted internationally on home visiting and community-based interventions.

## **GUEST FACULTY**

**Richard Dembo, Ph.D.**, is professor of Criminology at the University of South Florida in Tampa and is chair of the American Sociological Association Section on Substance Abuse Prevention. He is responsible for research at the Juvenile Assessment Center in Tampa (which he helped develop). He is working on a five-year NIDA Family Empowerment Intervention Program with high-risk youth and their families.

## **LOCAL FACULTY**

**Pedro Jose Greer, M.D.**, is founder and medical director of Camillus Health Concern, St. John Bosco and Penalver Clinic, a free walk-in health care clinic for the homeless in Miami-Dade County, and chief of Gastroenterology at Mercy Hospital. Dr. Greer has received numerous awards, including the prestigious MacArthur Fellowship and the 1997 Presidential Award. He is a trustee and chairman of the Rand Corporation Drug Policy Center.

**The Honorable Norman S. Gerstein**, Judge, Eleventh Judicial Circuit, Dade County, Florida, has served as a circuit court judge for 15 years. As an active advocate for children, the disabled, the elderly and crime victims, he has held positions on many boards and committees. He has been granted many honors and awards for his outstanding contributions.


